

Q102'S PICK YOUR PRIZE BONUS SWEEPSTAKES

Official Rules

BY ENTERING THE SWEEPSTAKES, EACH ENTRANT AGREES TO THESE OFFICIAL RULES.

- Eligibility:** The Q102 WKQR – "Q102's Pick Your Prize" Sweepstakes (the "Sweepstakes") is open only to individuals who are 18 years or older and residents of Indiana, Ohio or Kentucky who are 18 years of age or older and who reside within 120 miles of the WKQR Q102 studio located at 4800 Kennedy Ave, Cincinnati, OH 45209. No purchase necessary to enter the Sweepstakes. Employees of Hubbard Radio Cincinnati, LLC and its radio station 97.9 WRMF, (the "Sponsor"), Kroger, Mitchell's Salon & Day Spa, Little Miami Brewing Company, Genesis Diamonds, Bern's Garden Center (collectively, the "Promotional Participants"), Hubbard Radio, LLC, or any of their respective affiliates, subsidiaries, advertising agencies, or any other company or individual involved with the design, production execution or distribution of the Sweepstakes (collectively with Sponsor and Promotional Participants, the "Released Parties") and their immediate family (spouse, parents and step-parents, siblings and step-siblings, and children and step-children) and household members of each such employee are not eligible to enter or win. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Sweepstakes. - Sweepstakes Period:** The Sweepstakes starts at 12:00:00 AM Eastern Time ("ET") on September 20, 2021 and ends at 11:59:59 PM ET on October 29, 2021 (the "Sweepstakes Period").
- How to Enter:** To enter, listeners must visit www.wkqr.com ("Website") during the Sweepstakes Period to find the Sweepstakes mention. Then, find, complete and submit the online entry form on the Website. Then, there are three (3) additional ways to receive bonus entries into the Sweepstakes: (1) **YouTube:** subscribe to the Q102 YouTube Channel and automatically receive 15 bonus entries into the Sweepstakes; (2) **TikTok:** visit Q102 on TikTok and log in by filling out your full name and email address in the form to receive ten (10) bonus entries into the Sweepstakes, and (3) **Refer-A-Friend:** find the select the Refer-A-Friend icon on-screen and for each friend you refer, you will receive five (5) bonus entries into the Sweepstakes. Limit one (1) entry per person/household per method of entry during the entire Sweepstakes Period. All entries must be submitted by 11:59:59 PM ET on October 29, 2021 to be eligible for the Sweepstakes.
- How the Winner is Determined:** Then, on or about November 1, 2021, Sponsor and Promotional Participant will randomly select one (1) Grand Prize winner from among all eligible entries received in the entire Sweepstakes Period. In the event of a tie, Sponsor will conduct a random drawing from among all tying entrants to determine the Grand Prize winner. Odds of winning depend on the number eligible entries that are received. Decisions of Sponsor are final and binding. The potential Grand Prize winner may be notified via email and/or telephone. Failure to respond to the winner notification within **three (3) days** will be deemed forfeiture of the Grand Prize and an alternate winner may be selected at Sponsor's sole discretion, time permitting. 5. **Prize and Approximate Retail Value (“ARV”) – One (1) Grand Prize** – \$500.00 cash. ARV: \$500.00. Prize consists of only those items specifically listed as part of the prize. No substitution allowed by winner, but Sponsor may substitute the prize, or any portion thereof, for a prize of equal or greater value at Sponsor’s sole discretion for any reason. All local, state, and federal and income taxes on the Prize are Winner’s sole responsibility. The winner is responsible for applicable taxes and fees. 7. **Participation Conditions/Release/Consent to use Likeness:** By participating, each participant agrees to: (a) comply with and be bound by these Official Rules and the decisions of the Sponsor which are binding and final in all matters relating to this Sweepstakes; (b) release and hold harmless the Released Parties from and against any and all claims, expenses, and liability, including, but not limited to, negligence and damages of any kind to persons and property, including, but not limited to, invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a participant’s participation in this Sweepstakes, and acceptance or use or misuse of prize; (c) indemnify, defend and hold harmless the Released Parties from and against any and all claims, expenses, and liabilities (including reasonable attorney’s fees) arising out of or relating to an entrant’s participation in the Sweepstakes and/or entrant’s acceptance, use or misuse of prize; and (d) allow Sponsor’s use for promotional purposes of his/her likeness, voice and/or address (city/state) without any additional compensation.

Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the participation process or the

operation of the Sweepstakes or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. 9. **Limitations of Liability:** The Released Parties as set forth above are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Sweepstakes; (2) technical failures of any kind, including, but not limited to, malfunctions, interruptions or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the participation process or the Sweepstakes; (4) technical or human error which may occur in the administration of the Sweepstakes or the processing of phone calls; or (5) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes or receipt or use or misuse of any Prize.
